

The validity of consent to operate granted vide no. CTOW/Varied /HSP /2022/17513317 dated 09/02/2022 valid upto 31/03/2023 under the Water (Prevention & Control of Pollution) Act, 1974 is hereby extended upto 15/03/2027 with same terms & conditions and special conditions that:-

- 1) The industry shall carry out activities for environmental improvements amounting to Rs. 10 lacs from the funds kept under CER Head by the industry in and around the area of the industry, as per indicative list prepared by the Board within 30-days.
- 2) The industry shall ensure that hazardous wastes of all categories are collected properly & disposed off to the authorized companies and shall maintain all the records as per provisions of HWM Rules.
- 3) The industry shall not throw burn or burry any solid wastes in open outside premises or in drain / water bodies.
- 4) The industry shall promote use of alternatives of single use plastics (SUP) and awareness to discourage use of plastic.
- 5) The industry shall ensure that there are no usages of single use plastic- thermocol disposable items such as water bottles / water pouches/water cups, plates, forks, spoons, straw etc. and single use decorating material made of plastic-thermocol or any other non-biodegradable material in the premises.
- 6) The industry shall properly handle and manage the solid wastages as per the provisions of the Municipal Solid Waste Rules 2016 and ensure that the solid waste is segregated & disposed of in an environmentally sound manner.
- 7) The industry shall also develop the vermicomposting composting to manage the biodegradable solid waste. PP shall not throw,
- burn or bury any solid wastes in open, outside premises or in drain / water bodies.

 8) The industry shall perform / promote its Corporate Environment Responsibility (CER) activities as well as use of alternatives of single use plastics (SUP) and awareness to discourage use of plastic (See attached banner/circular).
- 9) The industry shall ensure that there are no usages of single use plastic- thermocol disposable items such as water bottles / water pouches/water cups, plates, forks, spoons, straw etc. and single use decorating material made of plastic-thermocol or any other non-biodegradable material in the premises.
- 10) The industry shall properly handle and manage the solid wastages as per the provisions of the Municipal Solid Waste Rules 2016 and ensure that the solid waste is segregated & disposed of in an environmentally sound manner.
